There were no speakers for this item. Chair Sutton calls for a separate vote on this item. Michael Kyne reads into the record the staff recommendation from the staff report. V. Chair Burditt moves to approve in accordance with the staff recommendation. Comm. Heiler 2nds. Comm. Barnes lodges her opposition to the HAWP because she feels that it creates a false sense of history, the historic resources is gone and not the victim of demolition by neglect, it was the result of a tragic accident, by moving forward with the HAWP, this enables the owner to move ahead, but she believes it creates a situation where in the future the HPC will need to approve changes in the future and this is not a useful way for the HPC to use its time. Recommends that when there is a major act of loss outside of the owner's control, there should be a way to delist the resource. After further discussion, Chair Sutton calls for a roll call vote.
