SUBJECT: Historic Preservation Tax Credit Application – 2021 Historic Preservation Tax Credits – First Transmittal (Groups 1-5)

The Historic Preservation Office is proud to submit the enclosed 134 Historic Preservation Tax Credit Applications for the 2021 calendar year. Please note that we have received a total of 158 applications. We are sending this first transmittal for processing now as these applications have been approved by the HPC and we do not wish to delay their acceptance by your office. Our office is continuing to process the final 24 applications, and we will transmit those to the Department of Finance before the end of the year. The Historic Preservation Commission (HPC) determined that this transmittal includes approximately \$3,266,899.84 in eligible expenditures. For your convenience, summary sheets have also been enclosed that provide an overview of what the work entailed for each of the applications.

These applications are ready for final approval, pending your review. If you would be kind enough to inform the Historic Preservation Office of any changes in determined eligible/ineligible expenditures, it would be most appreciated, as the accurate reporting of these numbers is critical to our efforts in what is one of our flagship incentive programs.
