The meeting was called to order at 6:10 p.m.

Meeting minutes for March 2, 2023 were approved.

Action Items:

Glen Road Bridge (M-0148) over Sandy Branch – 60% Plans – Paul Tukey, Glenstone Museum

Committee reviewed comments from MCDOT consultant Stantec relating to bridge width, elevation, safety fencing, concrete abutments, and scour protection. Concerns were expressed by Glenstone over metal fencing, concrete and rip rap. Committee to write to MCDOT to address three aspects – natural product solution (wood) to chain-link fence, natural stone stacked to cover concrete wing wall, and natural stone as alternative to riprap. Aesthetically pleasing stone is requested. Rocky Powell (consultant) to provide Committee with Glenstone/MCDOT correspondence and suggestions. Glenstone recommends less maintenance for MCDOT downstream by installing vegetation/foliage along the stream banks. Motion passed by Committee.

Schaeffer Road Bridge (M-0137) – 30% Plans

MCDOT engineer Barry Fuss states in March 22 letter that none of the bridge can be saved, does not mention historic consultant but is using standard bridge engineering consulting firm. They will work with RRAC on railings and parapets. Bridge is currently classified as National Register Eligible. When receiving federal funding there must be a Cultural Resources Review which is required by law under the National Historic Preservation Act of 1966. SHA is responsible. This review has not begun. Leslie to introduce Christina via email to Kari Sprengeler at SHA who may be leading this review since the retirement of Anne Bruder. Laura/Leslie to construct email/memo to Tim Tamburrino of Maryland Historic Trust. Motion passed by Committee.



17215 Elmer School Road – Proposed Farm Driveway Jamisons not in attendance. Rural Legacy Easement property. Referral from the Soil Conservation District. Committee approved driveway based upon location over 100 feet north of the streambed along tree line, to be constructed in accordance with SCD guidelines. Motion passed by Committee.
