SUBCOMMITTEE ON ALTERNATIVE MATERIALS, FLOORING, ETC.

The Subcommittee met at 5:30 pm in the Wheaton Headquarters Auditorium. Members present were Vice Chair Burditt, Comm. Pelletier, Comm. Hains, Comm. Radu, and Comm. Doman. The Subcommittee minutes/notes are as follows:

"January 24th, reconvened at 5:35pm. Recapped highlights from last meeting. Acknowledged the receipt of James' memo from last meeting.

Back to Contributing Resources: For the back of the contributing resources don't make a distinction in the material characteristics and construction methods. Would not support pressure treated wood that is tongue and groove with presumption it is unpaintable—so long as it is painted it can be approved. Can also do pressure treated for outstanding or master plan sites so long as can be painted. Pressure treated would just need conditions for painting and follow up inspections. Make clear it has to be a smooth, plain, paintable surface. Absolutely no embossing or grain. If it is non historic, it can have decking, and all the newer materials.

For noncontributing houses: do not have to use traditional building methods. Still no embossing or grain on the front. Uniform finish and appearance of the material.

Open question: is there an end condition that we never want to see? (in regards to the conversation regarding Trex/Timbertech). Decided—we don't ever want to see the edge condition if they use Trex or Timbertech. Will ask to see the details of construction with the applications—i.e. the framing plans. No faux wood grain embossing and no reflective plastic or other material. On the back anything goes if it is not visible from the right of way. If visible, same provisions as the front.

Staff will work up a draft and committee will reconvene at the February 21st meeting."
