About the School Utilization Report

On November 16, 2020, the Montgomery County Council adopted the 2020-2024 Growth and Infrastructure Policy, formerly known as the Subdivision Staging Policy. The new policy requires the Planning Department to provide a School Utilization Report along with the Annual School Test to provide supplemental information about the utilization of the county's public school infrastructure.

The report consists of two main parts: a countywide component and an individual school component. Each part provides a graphic representation of the enrollment and capacity data of Montgomery County Public Schools and their facility utilization trends.

- The *Countywide Utilization Report* includes:
 - Trends of the countywide enrollment, capacity, and utilization rates of all schools collectively, for each school level.
 - Trends of the share of school facilities operating at various adequacy levels, for each school level.
 - A snapshot of single-family home sales, residential development and total housing units for each school service area.

- The *Individual School Utilization Report* includes:
 - Trends of past and projected enrollment, capacity, and utilization rates of individual schools.
 - Facility data, adjacent schools, and Annual School Test results of individual schools.

Data Sources & Modifications

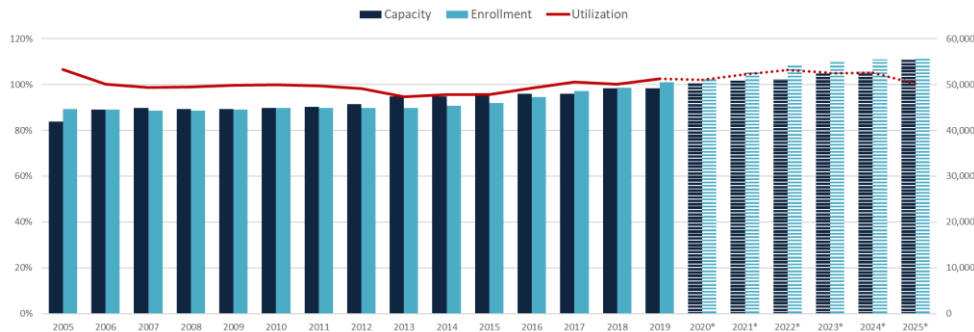
The source of data and method of modifications is consistent with the Annual School Test.

- Past trends are based on the actual enrollment and capacity data reported in 'MCPS Educational Facilities Master Plan and Capital Improvements Program' publications each fiscal year.
- Projected trends are based on the enrollment and capacity projections provided in the current fiscal year's educational facilities master plan publication. However, in schools where the projections do not reflect an approved capacity relief plan, the rules outlined in the Annual School Test Guidelines are used to make modifications. The modification is applied to each school year following the anticipated completion or execution of the capacity solution.



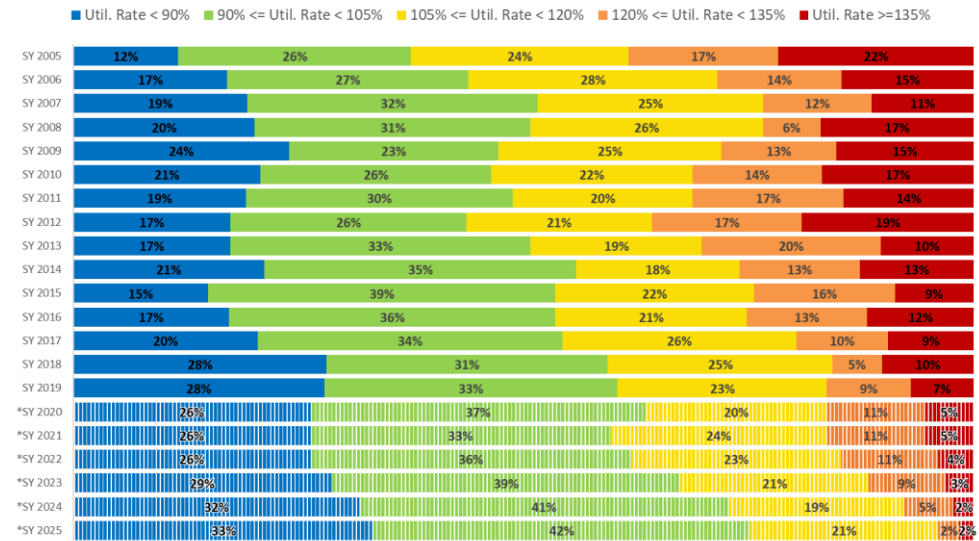
Countywide Data

There are two types of graphs currently provided in the Countywide Utilization Report related to schools. The first is a combination bar and line graph that shows past and projected enrollment and capacity trends for MCPS' elementary, middle or high schools collectively. The past trend shows actual enrollment and capacity of the last 15 school years. The projected trend shows enrollment and capacity data for the next five school years. This graph also includes a trend line that shows the countywide capacity utilization rate for the school level.



The second type of graph is a stacked bar graph that shows the distribution of the county's public elementary, middle or high

schools by utilization rate. Again, the graph shows actual enrollment and capacity of the last 15 school years, and projected utilization rates for the next five school years. The levels of utilization are based on the utilization rate thresholds used to determine Utilization Premium Payments.¹



Since FY 2022, a snapshot of housing data has been included, showing the total annual single-family home sales, residential development and total housing units for each school service area.

¹ Utilization Premium Payment requirements are determined as part of the Annual School Test and are based on the combination of an individual school's projected utilization rate and seat deficit four years in the future.



Individual School Data

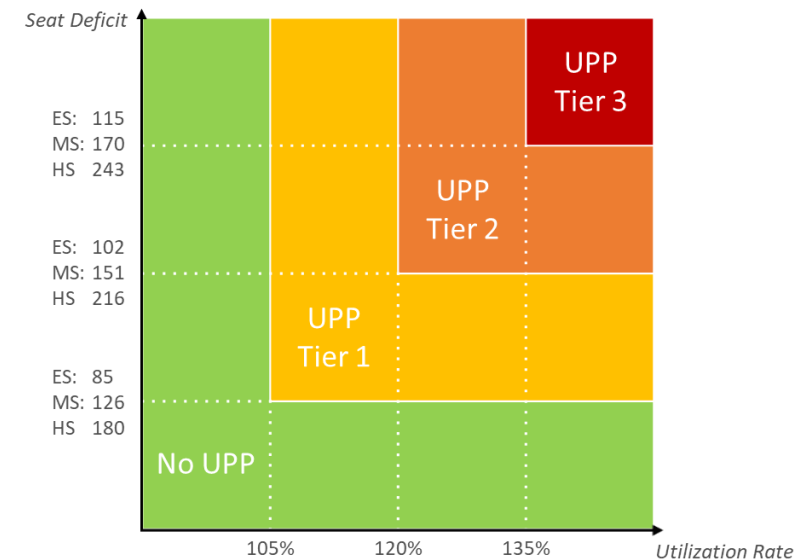
The Individual School Utilization Report includes one primary graph for each school. The combination bar and line graph shows the enrollment and capacity trends for the school – the actual trend of the last 15 school years, and the projected trend for the next five school years. This graph also includes a line that shows the corresponding rate of capacity utilization for the school.

In addition to the graph, information pertaining to the school facility and site are provided, including the year the facility was built, when the facility was last renovated and/or expanded, the facility's gross floor area and the size of the school site. The number of relocatable classrooms that were used to relieve overcrowding during the last school year is also included.

For each school, there is also a list of schools that share boundaries, and links are included to the corresponding page of each adjacent school.

Finally, information is provided regarding the status of the school in the Annual School Test. This includes identifying

what level of Utilization Premium Payment (UPP) is required, if any, for development approved in the school's service area. There is a graphic that demonstrates where the school's projected utilization falls relative to the UPP utilization rate thresholds and the seat deficit thresholds. In order to trigger a payment at a particular UPP tier, the projected utilization must meet the thresholds for both factors. The image below provides a visualization of how the UPP tier is determined based on the utilization rate and seat deficit thresholds.



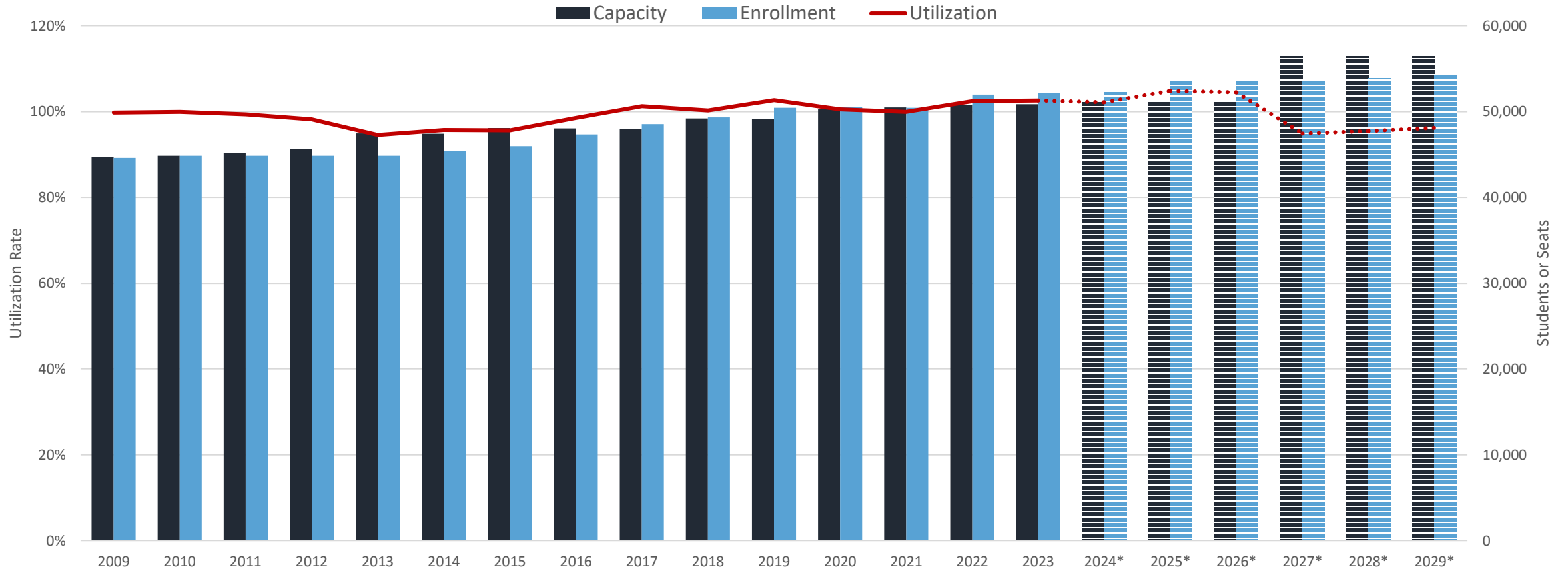
Future Utilization Reports

School Utilization Reports will continue to be released in June of each year. Over time, additional information will be included as data are collected, reviewed and prepared for presentation. Such data may include information on individual school core capacity, as well as countywide trends in the use of relocatable classrooms. Trends in housing by school service area may also be provided to better demonstrate connections between these trends and school enrollment. The reports may also move to a purely digital format with interactive graphs.

High Schools – Countywide Enrollment/Utilization Trend



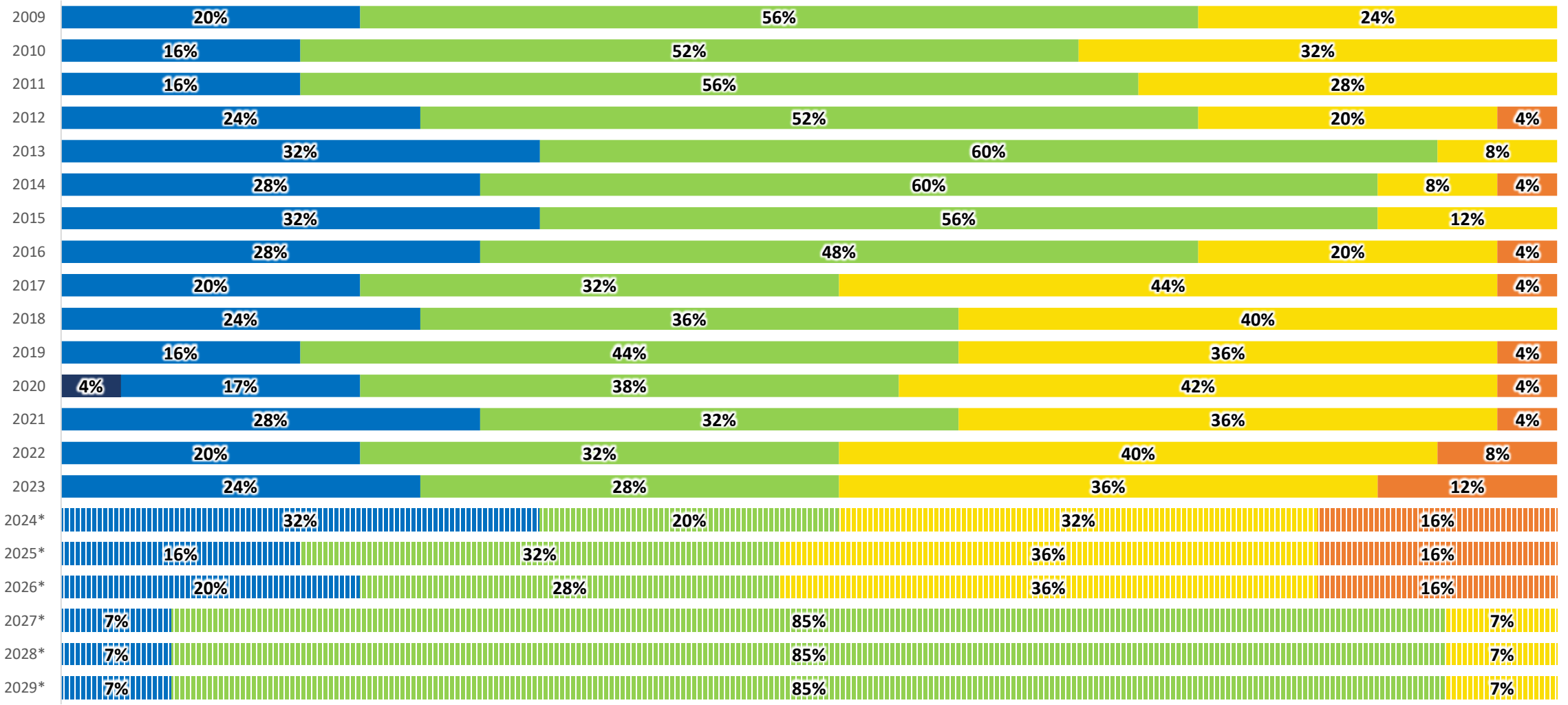

High Schools – Individual School Utilization Level Trend

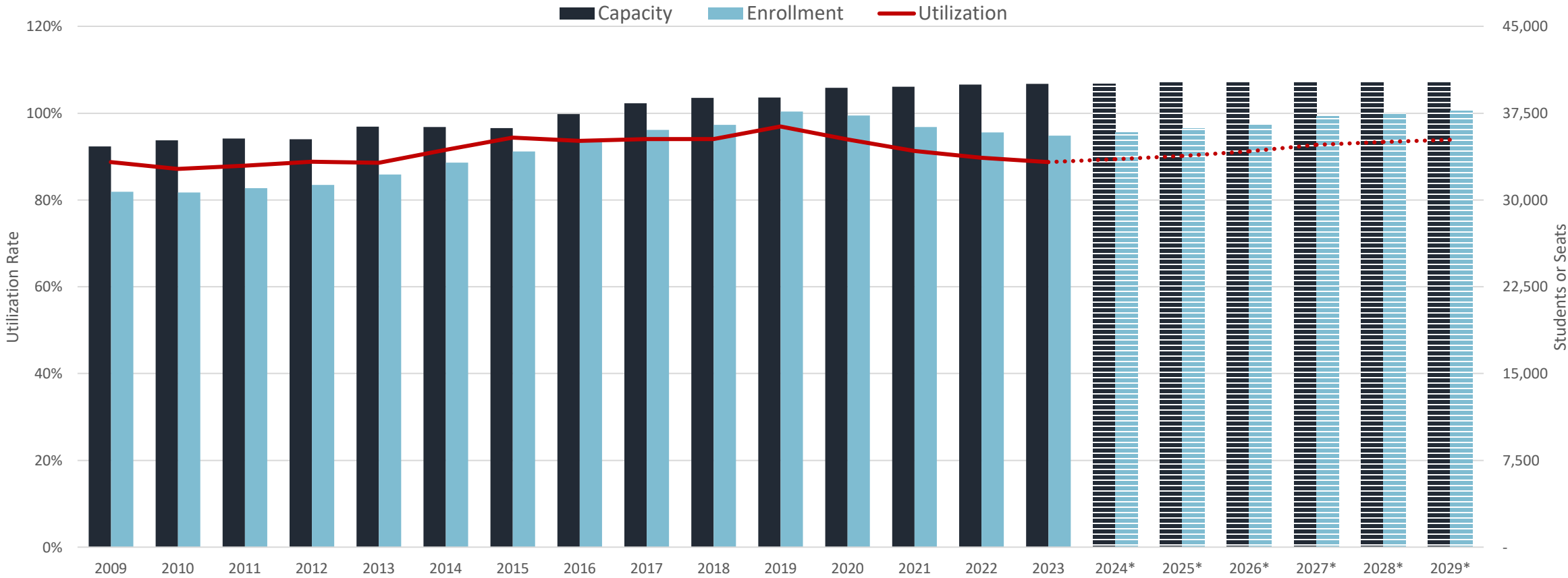

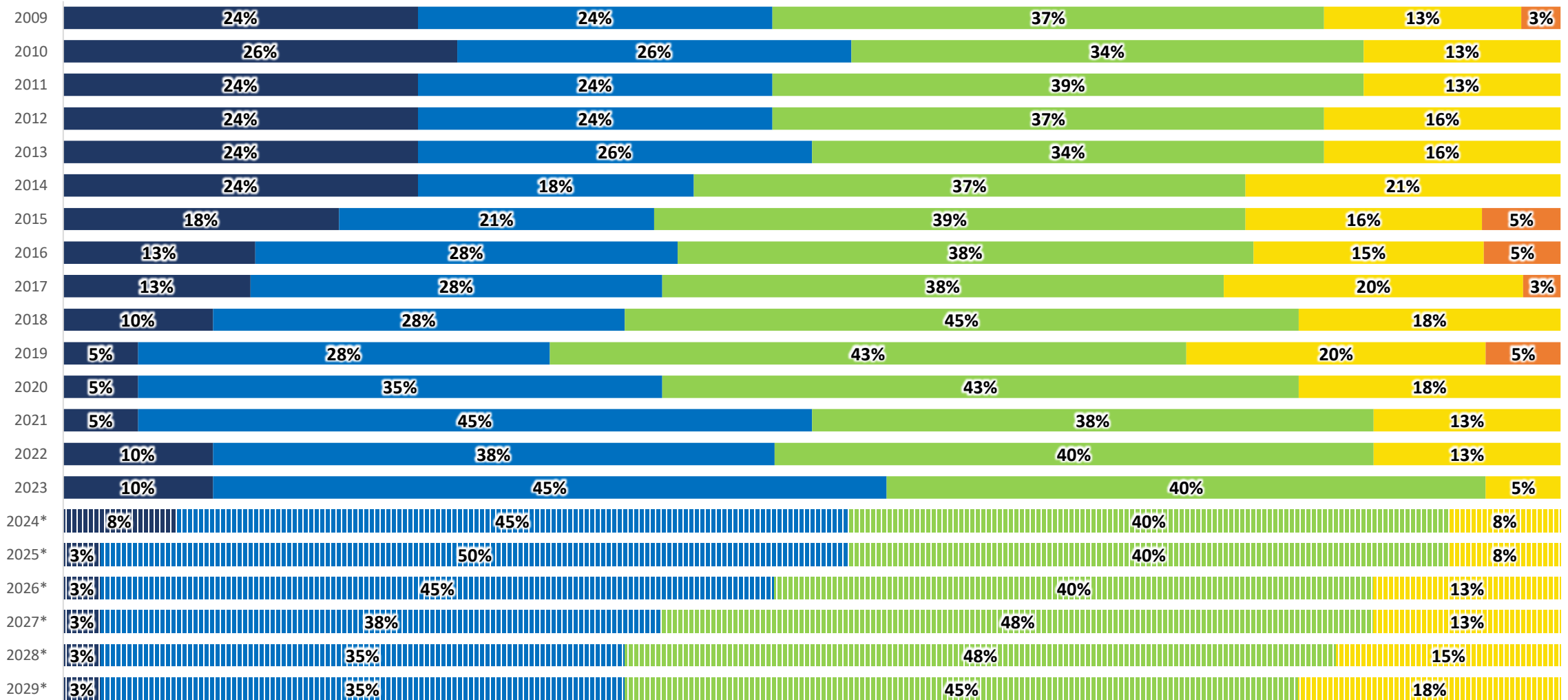

Middle Schools – Individual School Utilization Level Trend

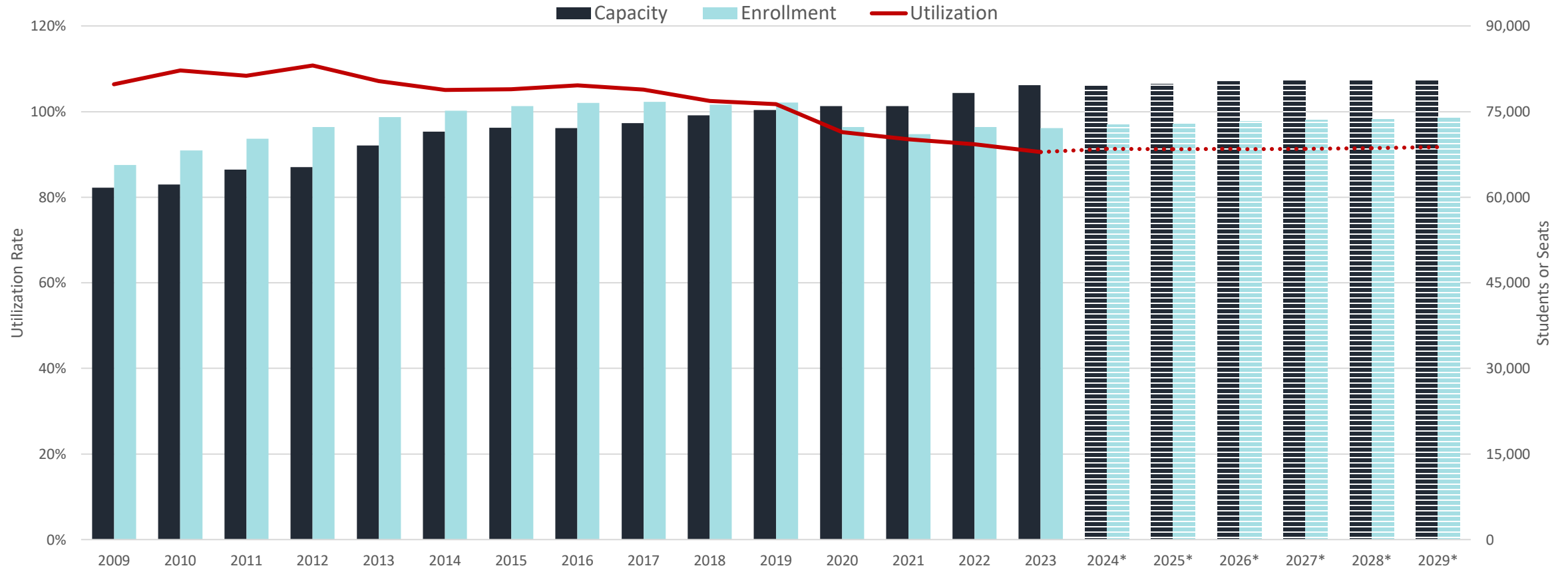

Elementary Schools – Countywide Enrollment/Utilization Trend

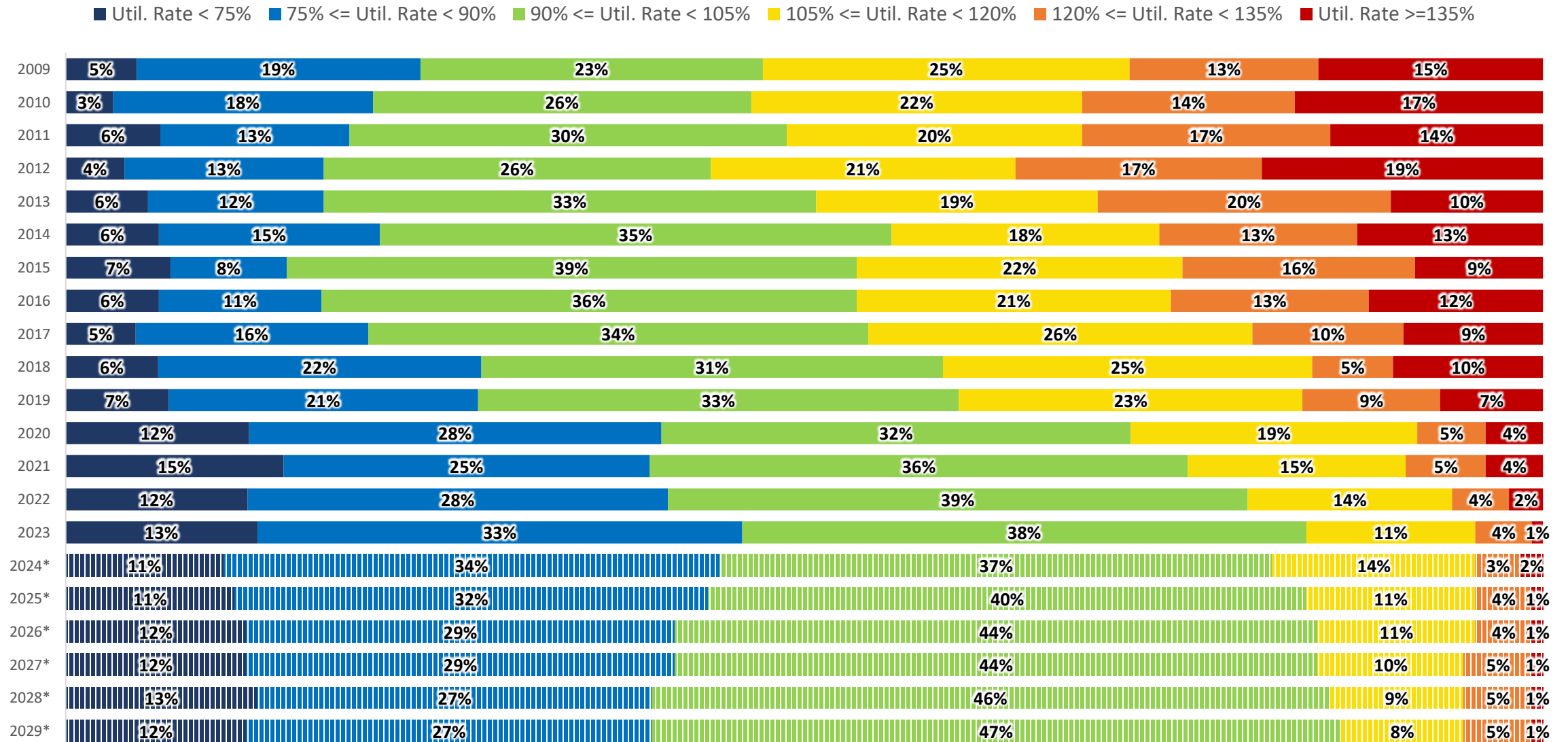

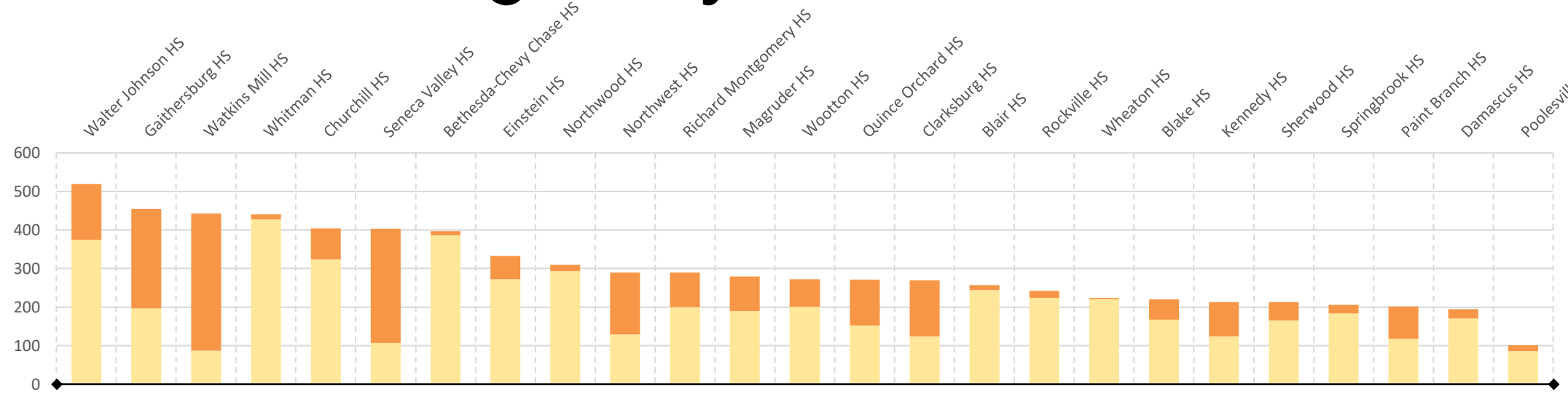
