- 1. That this Agreement shall be appended to the Conservation Easement and make the Agent liable for all terms, conditions, and restrictions contained therein.
- 2. That the obligations set forth herein and in the Conservation Easement are being assumed by the Bank Owner in satisfaction of Developer's requirements under the forest conservation law and as set forth in the FCP.
- 3.
