Jerusalem Road Site Visit Recap

The committee met with Donald Noble and MCDOT team. Discussion ensued about how the Division of Highway Services chooses the priority of resurfacing projects. This project was prioritized due to written complaints from the Town of Poolesville.

Executive Regulations Discussion

Dick Thoms did research of the County Code to find that Rustic Roads should have a target speed of 30 mph. Out of 31 roads checked only six meet the target rate of speed. Discussed the results of Peach Tree Road speed study which lead to lowering the speed would cause a traffic hazard. Target speed as defined in the Complete Streets Design Guide is the speed goal to be met following revisions to any road. It is not a set requirement for the speed limit on an existing road to be changed without additional improvement. Chris to find out the specific reason the speed study resulted in no change. What other speed control measures are there to reduce speeding on Rustic Roads? Chris to ask Traffic Ops to come to next meeting to explain how speed limits are changed.
