## **Discussion Items**

## Upcoming Bridge Projects – Gregg Road Bridge and Cattail Road Bridge

*Gregg Road Bridge* M0119 built in 1958. Project will be replacing beams and deck only. Because of the width cannot do a staged improvement, this will result in road closure for approximately 3 months. There will be no widening or tree loss with the project.

Laura Van Etten suggests getting a new copy of the Bridge Book. Brian has a draft that he will get published. Will get updates from Laura regarding bridges and road designations.

Further discussion revealed interest to widen the road 1-2 feet and to potentially push back the guardrail on these types of roads. There will be a virtual public meeting in March to take comment from the surrounding community.

Motion passed to postpone decision on Gregg Road bridge until next RRAC meeting.

*Cattail Road Bridge* M0491 built in 1975. Replacement bridge. The project will update the road profile to be raised by 6 inches. No widening of the roadway is proposed at any point. They will install a 3-cell concrete box culvert to resist flooding. As of now the specs will support at least 80,000 lbs. Project to begin in 2 years.

Motion to approve design as submitted with guardrails pushed back four inches on each side while reserving the 20 ft. wide clear road cross section.

# **20800 Mouth of Monocacy Road – Farm access** road permit for farm field equipment (no development proposed)

Presented by Nick Magliato. The goal is to create a pathway between the two ag fields on either side of the road. This will help move equipment around without having to dismantle apparatuses. Motion approved the plans as presented to the committee. Chris to send email to DPS in support of application.

## **Discussion of Rustic Road Speeds**

The topic was postponed to a later meeting.

## **Discussion of Road Pavement Width**

Discussion focused on issues related to road width. Existing widths often are too narrow to accommodate large farming equipment. However, as noted often times the narrow width of the road is an important feature defined in the Rustic Roads plan. Some discussion pointed to the need instead for improved shoulders. RR regulations provide flexibility to widen road for passage of farm equipment. Overall, this points to the need for more case-by-case analysis of rustic roads to determine when and where limited widening is appropriate.

## **Discussion of Roadside Vegetation**

Send images or requests to Michael Nesselt at MCDOT for vegetation concerns. Discussed getting a small group of roads to partner with MCDOT to review for foliage improvements. Billy Willard, Mason Hopkins, and Tom Linthicum to makeup the subcommittee.
